

## Attachment No. 3 to Regulation No. 7/2015 of 18 May 2015

## RULES AND REGULATIONS OF THE ICE RINK

- 1. The ice rink is managed by the Sports and Recreation Center in Mszczonów.
- 2. The ice rink is open to school groups from the Mszczonów commune from Monday to Friday from 9:00 13:00.
- **3.** The ice rink is open to individual customers: from Monday to Friday from 14:00 to 21:00, on Saturdays, Sundays and days off from school, from 9:00 to 21:00.
- **4.** From 13:00 to 14:00 the ice rink is excluded from use for the purpose of maintenance of the ice rink. All persons must leave the ice sheet during maintenance breaks.
- 5. The ice rink is open to the public, it is open according to the schedule set by OSiR Mszczonów. In the case of renting or organizing events, OSiR reserves the right to change the schedule of using the ice rink.
- 6. In addition, 10 minutes of technical free time for the Guest is added.
- 7. Up to 60 people can stay on the ice rink at the same time.
- 8. Persons using the ice rink are obliged to comply strictly with the recommendations resulting from the regulations and the instructions of the rink maintenance services.
- **9.** Children under 10 years are allowed to use the ice rink only in a helmet and under the supervision of adults who are skating.
- **10.** Persons using the ice rink are required to exercise extreme caution while skating, which should take place in one direction.
- 11.Persons using the ice rink are forbidden to: pose a threat to other participants; sit on bands surrounding the ice rink; throw snow; skate with children on hands; bring and consume food on the ice rinks; destruct of equipment and devices; create dangerous situations for other ice rink users, skate against the current; organize races and dangerous games.
- **12.** It is forbidden to bring and consume alcoholic beverages, stay in the state indicating alcohol consumption and smoking.
- **13.** Any observed damage or hazards should be immediately reported to the ice rink personnel.

- **14.** There is a changing room in the ice rink. The administrator of the facility is not responsible for things left in the changing room of the ice rink.
- **15.**Only on the surface of the ice rink and in places lined with rubber carpet it is allowed to stay with your skates on.
- 16. If damage is found, the person responsible for the damage will be charged for it.
- **17.**In order to obtain first medical help, please report to an ice rink maintenance worker.
- 18. Persons using the ice rink bear the risk related to amateur skating.
- **19.** For the destruction, damage or loss of the helmet, a fee of PLN 30 is required.
- 20. For the destruction, damage or loss of skates, a fee of PLN 70 is required.
- **21.** For loss, damage or loss of the strap with coding reader, a fee of PLN 100 is required.
- **22.**Skates and a helmet are rented for a refundable deposit in the amount of skates: PLN 70, helmet: PLN 30.
- **23.**Persons who do not comply with the provisions of these Regulations shall be removed from the ice rink.
