

## TERMS AND CONDITIONS OF THE SKATING RINK

- 1. The skating rink is under the management of by the Sport and Recreation Centre in Mszczonów.
- 2. The skating rink is open daily from 9:00 a.m. 8:00 p.m.
- 3. In hours 3:00 p.m. 4:00 p.m. the skating rink is closed for the purpose of maintenance works of the rink surface. In the course of breaks for maintenance the rink surface, all persons shall have to leave the ice surface.
- **4.** The skating rink is available to anyone, and open in accordance with the timetable determined by the Sports and Recreation Centre in Mszczonów. In the case of renting or organizing events, the Sports and Recreation Centre hereby reserves itself the right to change the timetable of entering and using the skating rink.
- 5. The surface of the skating rink may accommodate no more than 60 persons simultaneously.
- **6.** Persons using the skating rink are hereby obliged to rigorously comply with the instructions resulting from these Terms and Conditions, and also to perform the instructions of the order-keeping services of this skating rink.
- 7. Children under the age of 10 may use the skating rink only in a safety helmet, and also under the supervision of persons that have come of age, and that are wearing skates.
- 8. Persons using the skating rink are hereby obliged to maintain particular care in the course of skating. Skating ought to be performed in the same direction.
- 9. For persons using the skating rink it is hereby not permitted to:
  - constitute a threat the participants using the skating rink;
  - to sit down on the fences surrounding the skating rink;
  - to throw snow;
  - to skate while carrying children in their arms;
  - to enter the skating rink with food, and to consume it on the surface of the skating rink:
  - to destroy the equipment and devices of the skating rink;
  - to cause situations which are dangerous for the users of the skating rink;
  - to skate in the 'against the tide' direction;
  - to organize or engage into races, or other dangerous entertainment activities.
- **10.** On the premises of this facility, it is hereby not permitted to enter and consume liquors or spirits, to stay in the state indicating that liquors or spirits have been consumed, and also to smoke tobacco.
- 11. It is hereby required that all and any noticed damage or threats are the subject of notification of the service staff of the skating rink.
- 12. On the premises of the skating rink, a cloakroom is situated. The administrator of this facility shall not bear responsibility for the items left in the cloakroom of the skating rink.



- 13. It is hereby permitted to wear skates only on the surface of the skating rink, and also in the places covered with a rubber fitted carpet.
- 14. In the case of ascertaining that a damage has been caused, the person responsible for causing the damage in question shall be requested to cover the expenses relevant to it.
- **15.** In order to obtain medical first aid, it is hereby required to report to the member of the service staff of the skating rink.
- **16.** Persons using the skating rink shall bear the risk connected with engaging in amateur skating.
- **17.** It is hereby obligatory to effectuate the payment of the amount of 100.00 Polish zlotys for destroying, damaging or losing of the strip with coding reader.
- **18.** Persons failing to comply with the provisions of these Terms and Conditions shall be requested to leave the skating rink.
